# United Arab Emirates' New Standards: "English as an International Language (EIL)"

In UAE, the Ministry of Education has produced their own "National Unified K-12 Learning Standards Framework", which they will implement in all their school classrooms this year. Their ultimate goal is to produce highly educated, 'World Class' citizens. Recognizing English as an international language, the Ministry has strongly recommended that no less than one hour per day is allocated to the teaching of English at every grade level.



To ensure that these new standards reflect world-class expectations, the

development process drew from the 1) existing UAE English standards, and 2) K-12 English standards from Australia, the United Kingdom, New Zealand, and the United States' Common Core State Standards. The resulting UAE Performance Standards focus on 4 Domains - Listening, Speaking, Reading, and Writing, and the various skills manifested in each of these domains. correlation.edgate.com

#### California researchers call for an end of highstakes testing

Researchers from public and private universities in California believe highstakes test can actually harm some low-achieving students and minorities.

Proposal to count coding as foreign language Regarding assessment of these standards, the Ministry drew from specifications for the Programme for International Student Assessment (PISA), the United States National Assessments of Educational Progress in Reading and Writing, The Common European Framework for Languages (CEFR): Learning, teaching and assessment, and the British Council's EAQUALS Core Inventory for General English.

In addition, UAE students learning English are expected to meet international benchmarks according to the Test of English as a Foreign Language (TOEFL) levels, and the International Test of English Language System (ITELS).

EdGate is currently in the process of adding these well thought out standards to our repository at the request of clients, and they will be available fairly soon!



# **Hot Topic**

#### **Debate Over Advanced Math**

Andrew Hacker is professor emeritus of political science at Queens College, City University of New York and he asks, "I have three coins. How much money COULD I have?" To answer this question, a student needs more than basic math skills. Andrew suggests that not all students need to learn how to answer the question. He is a proponent for teaching basic math skills or numeracy to the general



student population and not require advanced mathematic, like algebra, trigonometry and calculus. Andrew's concern is that the Common Core State Standards are expecting everybody to achieve SAT levels in math. He says that many people do not graduate from high school because they cannot pass algebra and it should not be a graduation requirement because only a small portion of the population needs algebra skills. He does not support the concept that there is a skills gap in STEM. When asked about the need for more people with STEM skills, Andrew agrees that more people are needed who know how to code, and further states that we're producing all the engineers we need.

#### **Arts Education and Arts Standards**

According to <u>Marinell Rousmaniere</u>, senior vice president for strategic initiatives at EdVestors, Boston has been highly successful in bringing arts education back into the public schools. Research showing a strong connection between early arts education and success in both college and future careers motivated the city to partner



with both public and private organizations to increase student access to the arts.

A January 2016 Education Commission of the States report found state funding for preschool programs increased in 32 states and in the District of Columbia by a total of \$755 million between 2015 and 2016.

In the past six years Boston Public Schools, backed by educational grants and financial support from its partners, has provided annual arts education to 14,000 students from Pre-K through eighth grade. Arts instruction in the high school has increased from 26 to 60 percent. A recent survey by EdVestors clearly shows that arts education has led to "greater student and parent engagement and a richer school climate."

The success of the arts program in the Boston School System will provide the city with future citizens whose creative abilities will enable them to maintain the cultural heritage of the city. The results of a recent survey indicated that parents believe there is a strong correlation between arts education and their students' success in academic subjects. The Arts Expansion Initiative, recognized by the National Endowment for the Arts, has been so successful it has prompted other cities to introduce similar programs.
